Sam Bahour



Sam Bahour is a Palestinian-American business consultant based in Al-Bireh/Ramallah, Palestine. His firm, Applied Information Management (AIM), specializes in business development with a niche focus on start-ups and providing executive counsel. Sam was instrumental in the establishment of the Palestine Telecommunications Company (PALTEL) and the PLAZA Shopping Center. He completed a full term as a Board of Trustees member at Birzeit University and is currently a Director at the Arab Islamic Bank and serves in various capacities in several community organizations, including as a policy adviser to Al-Shabaka, the Palestinian Policy Network, member of the core Local Reference Group of the Ecumenical Accompaniment Programme in Palestine and Israel (EAPPI), co-founder of the community foundation, Dalia Association, and Chairman of Americans for a Vibrant Palestinian Economy. Sam writes frequently on Palestinian affairs and has been widely published. He is co-editor of HOMELAND: Oral History of Palestine and Palestinians and may be reached via the blog www.epalestine.com.

Mustafa Barghouthi



Dr. Mustafa Barghouthi was born in Jerusalem in 1954 to a Palestinian family from Deir Ghassaneh village in the Ramallah District. He is a member of the Palestinian parliament and was a presidential candidate in 2005 and Minister of Information under the first National Unity Government in Palestinian history. Mustafa Barghouthi has made an extraordinary contribution to initiatives to peacefully challenge the ongoing Israeli Occupation of Palestine and bring it to end, as well as efforts to build the institutional framework of Palestinian civil society and promote the principles of internal democracy and good governance. He writes extensively for local and international audiences on civil society and democracy issues and the political situation in Palestine, as well as on health development policy in Palestine. Dr. Barghouthi is also one of the leading exponents of the campaign for economic and political divestment from Israel and its associated institutions. With a long history of involvement in the Palestinian political sphere, Dr. Barghouthi was a member of the Palestinian delegation to the Madrid Peace Conference in 1991. He was also a member of the Steering Committee to the Multilateral Peace Negotiations from 1991-93. He drafted the Palestinian NGO law and participated in lobbying efforts to have it passed by the Palestinian Legislative Council. 2002, Barghouthi co-founded the Palestinian National Initiative.



Bashir Bashir



Bashir Bashir is a research fellow at the Van Leer Jerusalem Institute and teaches political philosophy in the Department of Political Science at the Hebrew University of Jerusalem. His primary research interests are nationalism and citizenship studies, multiculturalism, conflict-resolution and the politics of reconciliation. His publications include: 'Reconciling Historical Injustices: Deliberative Democracy and the Politics of Reconciliation', Res Publica, 18(2), 2012: 127-143; with Amos Goldberg, 'Deliberating the Holocaust and the Nakba: Disruptive Empathy and Binationalism in Israel/Palestine', Journal of Genocide Research, 16(1), 2014: 77-99; with Will Kymlicka (eds.) The Politics of Reconciliation in Multicultural Societies (Oxford: Oxford University Press, 2008).

Brenna Bhandar is Senior Lecturer in Law, SOAS. She has published widely in the areas of critical legal theory, indigenous rights, and property law. She is co-editor of the forthcoming book, Plastic Materialities: Legality, Politics and Metamorphosis in the work of Catherine Malabou (Duke University Press, 2015).

Geoffrey Bindman QC



Sir Geoffrey Bindman QC, throughout his long and distinguished legal career, has specialised in civil liberty and human rights issues. From 1966-1976 he was legal adviser to the Race Relations Board and from 1976-1983, to the Commission for Racial Equality. He is a Visiting Professor of Law at University College London and at London South Bank University, an Honorary Fellow in Civil Legal Process at the University of Kent, and a Fellow of the Society of Advanced Legal Studies. He is chair of the Board of Trustees at the British Institute of Human Rights. He has won awards for a lifetime's achievement in human rights from Liberty (December 1999) and the Law Society's Gazette (October 2003). He has represented the International Commission of Jurists, the International Bar Association, Amnesty International, and other bodies in human rights missions in countries, including the former Soviet Union, Germany, South Africa, Chile, Uganda, Namibia, Malaysia, Israel and the Occupied Territories, and Northern Ireland. He was knighted in January 2007 for services to human rights and in March 2011 appointed honorary Queen's Counsel.

Moshe Behar

Moshe Behar is senior lecturer in the Department of Middle Eastern Studies at the University of Manchester and co-editor of Modern Middle Eastern Jewish Thought, Writings on Identity, Politics and Culture, 1893-1958 (2013).



Avraham Burg



Avraham (Avrum) Burg was born in Jerusalem 1955. An Israeli author and activist, he was formerly a member of the Knesset, Chairman of the Jewish Agency for Israel and Speaker of the Knesset. Burg was the first Speaker of the Knesset to have been born in Israeli territory after independence in 1948. Then a member of the Labor Party, he retired from the Knesset in 2004 and has published several Israeli and internationally best sellers. Burg is a regular contributor to the leading newspaper articles in Israel as well as appearing on TV programs in Israel, and around the world. Burg is the chairman of 'Mifalot' the largest Israeli movement for social change through sports and education.

Taghreed El-Khodary



Taghreed El-Khodary was born in Gaza and holds an undergraduate degree in communications from the American University in Cairo and an MS in mass communication from Murray State University, which she attended as a Fulbright Scholar. El-Khodary later returned to the U.S. to take up a Nieman Fellowship at Harvard University in 2006 as the Ruth Cowan Nash Fellow, and again in 2010 as a Heinrich Boell Fellow and Visiting Scholar with the Carnegie Endowment for International Peace. She covered Gaza for the New York Times for 8 years (2001-2009). She also worked for ICG as an analyst in Gaza. She covered the second intifada, the civil war, the Israeli war on Gaza (Cast-lead operation) . El-Khodary has been working as a senior editor for a chronicle on the Middle East and North Africa www.fanack.com. Fanack is based in The Hague.

Leila Farsakh



Leila Farsakh is Associate Professor of political science at the University of Massachusetts Boston. She is the author of Palestinian Labor Migration to Israel: Labour, Land and Occupation, (Routledge, fall 2005, 2012) and editor of Commemorating the Naksa, Evoking the Nakba, (a special volume of Electronic Journal of Middle Eastern Studies, in Spring 2008), as well as of numerous journal articles on the political economy of the Israeli-Palestinian conflict and on the One-State solution. Dr. Farsakh holds a Ph.D. from the University of London and an M.Phil from the University of Cambridge, UK. She has also worked with a number of international organizations, including the Organization for Economic Cooperation and Development (OECD) in Paris and since 2008 has been a senior research fellow at the Center for Development Studies at Birzeit University, in the West Bank. In 2001 Dr. Farsakh won the Peace and Justice Award from the Cambridge Peace Commission, in Cambridge-Massachusetts.

Salma Karmi-Ayyoub



Salma Karmi-Ayyoub is a criminal barrister and external consultant for the Palestinian human rights organisation Al Haq, where she used to head an international litigation project. She has a particular interest in the question of Palestine and the International Criminal Court. She is also co-chair of the British legal charity Lawyers for Palestinian Human Rights.



Menachem Klein




Prof. Menachem Klein is a faculty member in the Department of Political Science at Bar-Ilan University, Israel. Prof. Klein studied Middle East and Islamic Studies at the Hebrew University of Jerusalem. In 1992-3 and 2001-2, he was a fellow at St. Antony's College, Oxford University, in 2006 visiting professor at MIT, and in 2010, Fernand Braudel Senior Fellow at the European University Institute, Florence. In 2011 Prof. Klein was a visiting scholar in Leiden University, Holland, and in 2015 he is a Visiting Research Fellow in King's College London. In 2000 Prof. Klein was an adviser for Jerusalem Affairs and Israel-PLO Final Status Talks to the Minister of Foreign Affairs, Prof. S. Ben-Ami, and a member of advisory team operating in the office of Prime Minister Ehud Barak. Since 1996 he has been active in many unofficial negotiations with Palestinian counterparts. In October 2003 Prof. Klein, together with prominent Israeli and Palestinian negotiators, signed the Geneva Agreement - a detailed proposal for a comprehensive Israeli-Palestinian peace accord. He is Senior Fellow at the Bruno Kreisky Forum for International Dialogue and board member of Palestine – Israel Journal. Previously he was board member of B'etselem, The Israeli Information Center for Human Rights in the Occupied Territories.

Francesca Klug



Francesca Klug is a Professorial Research Fellow and Director of the Human Rights Futures Project at the LSE's Centre for the Study of Human Rights. As a Senior Research Fellow at King's College Law School in the 1990s she advised the then Government on the model for incorporation of the European Convention on Human Rights into UK law reflected in the Human Rights Act. Francesca was a Commissioner on the Equality and Human Rights Commission from 2006-09 and was a member of the small Bill of Rights and Responsibilities Reference Group at the Ministry of Justice from 2007-09. Her latest book *A Magna Carta for all Humanity: homing in on human rights* will be published by Routledge in May.

Tony Klug



Tony Klug, a special advisor on the Middle East to the Oxford Research Group, has written extensively about the Israeli-Palestinian conflict. His doctoral thesis was on the Israeli occupation of the West Bank during its early years. He is a former co-chair of the Council for Jewish-Palestinian Dialogue and the Arab-Jewish Forum and was a founder member of Independent Jewish Voices. For many years he worked at the International Secretariat of Amnesty International.

Alon Liel



Dr. Alon Liel is the former Director General of the Ministry of Foreign Affairs, Chairman of the Israel-Syria Peace Society, and lecturer in International Relations at Tel Aviv University and the Herzliya Interdisciplinary Center. Dr. Liel held numerous positions in the Foreign Ministry, including the Israeli Ambassador to South Africa, Foreign Ministry Spokesman, and Charge D'affairs of Israel in Turkey. He is a member of the board of several civil society organizations, which promote peace and equality, including One Voice. In addition Dr. Liel has published several books, including: Demo Islam, Islamic Democracy in Turkey, Turkish-Israeli Relations 1949-2010, and The Equalizer — South Africa is Building a Nation.



Michelle Pace



Michelle Pace is Professor with Special Responsibilities at the University of Roskilde's Department of Society and Globalisation. Her main areas of research include the External Relations of the European Union with special emphasis on relations with the Middle East and North African (MENA) region. She is also Honorary Professor in Politics and International Studies at the University of Birmingham in the UK. Her research interests cover identity politics, perceptions of democratisation in the MENA, the development of the public sphere in this region since the Arab "Uprisings", de-democratisation, governance and pluralism in the Middle East, Egypt, Palestine. Recent projects she was principal investigator on include a British Academy funded project on A 'Modern' Islamist Democracy? Perceptions of democratization in the Arab-Mediterranean world and an ESRC funded project on Paradoxes and Contradictions in EU democracy promotion efforts in the Middle East. She has supervised a study of the Danish Arab Partnership Programme and is the academic evaluator for the Danish policy towards Palestine. She is co-editor of the peer reviewed journal Mediterranean Politics. She was founder and convener of the British International Studies Association Working Group on International Mediterranean Studies (until 2013) and of the research group on the EU and democracy promotion efforts in the Middle East (2008 - to date).

Yossi Rapoport



Yossi Rapoport is Reader in the history of the Middle East and the Islamic World at Queen Mary University. His academic publications deal with the history of women in Islam and of Islamic law. He has also written on the Arab Spring and the territorial unity of Eretz Israel/Palestine. He is a member of the Israeli-Palestinian group "Two States, One Homeland".

Philippe Sands



Philippe Sands QC is Professor of Law at University College London and Director of the Centre for International Courts and Tribunals, and a practising barrister and co-founder of Matrix Chambers. He acts in cases before international courts and tribunals, including the International Court of Justice, and sits as an arbitrator in international investment disputes (ICSID) and on the Court of Arbitration for Sports. He is the author of several books, including Principles of International Environmental Law (CUP, 3rd edition, 2012), Bowett's Law of International Institutions (Sweet & Maxwell, 6th ed. 2009), Lawless World (2005) and Torture Team (2008), and contributes to the New York Review of Books, Vanity Fair, the Financial Times and The Guardian. His new book, a personal history of the Nuremberg trial and the origins of 'crimes against humanity' and 'genocide', will be published by Alfred Knopf in 2016. He is a member of the Foreign and Commonwealth Office's Panel on Diplomatic Excellence, a vice president of the Hay Festival, a member of the board of English PEN and of the Tricycle Theatre, and serves on the appeal board of the Bingham Centre for the Rule of Law.



Lynne Segal



Lynne Segal has been engaged in Left & feminist politics since coming to London from Sydney in the early 1970s. She is currently a Professor in Psychosocial Studies at Birkbeck, University of London. She has written many books on feminism, gender and politics. Her two most recent books are Making Trouble: Life and Politics and Out of Time: The Pleasures & Perils of Ageing. She was amongst the founding group of both Jews for Justice for Palestinians & Independent Jewish Voices in the UK.

Leila Shahid



Leila Shahid studied sociology and anthropology at the American University of Beirut (AUB), one of the centres of Palestinian political activism. At the same time, she joined the movement of Yasser Arafat in 1968. In 1976, she became the President of the General Union of Palestinian Students in France. She participated in the launch of the French quarterly, La Revue d'études palestiniennes, which was published until 2008. The first woman to be appointed by Yasser Arafat to represent the Palestine Liberation Organisation (PLO) in Ireland in 1989, she then became the PLO's representative to the Netherlands in 1990 before being appointed General Delegate of Palestine to France, from 1993 to 2005 and to UNESCO from 1993 to 1996. She has been Ambassador of Palestine to the European Union, Belgium and Luxembourg since 2005. Leila Shahid is also a Patron of the Support Committee of the Russell Tribunal on Palestine, which began its work in 2009, and member of the Board of Trustees of the Institute of Palestinian Studies and the Board of Trustees of Bir Zeit University. Leila Shahid is married to Moroccan novelist and literary critic Mohammed Berrada.

Avi Shlaim



Avi Shlaim is an Emeritus Fellow of St Antony's College and Professor of International Relations at the University of Oxford. He is a Fellow of the BritishAcademy. His books include The Politics of Partition (1990); The Iron Wall: Israel and the Arab World (2000), Lion of Jordan: The Life of King Hussein in War and Peace (2007), and Israel and Palestine: Reappraisals, Revisions, Refutations (2009).

John Strawson



John Strawson works in the areas of colonial legal history and postcolonialism with interests in international law, the Middle East and Islamic law. He is co-director of the Centre for Human Rights in Conflict at the University of East London, and has held visiting positions at the International Institute of Social Studies (The Hague, Netherland), Birzeit University (Palestine) and was Visiting Professor of Law at the International Islamic University Malaysia (Kuala Lumpur) in 2007. He broadcasts on international Law, Middle East politics and Islamic law. His publications include: Partitioning Palestine: Legal Fundamentalism in the Palestinian-Israeli Conflict (London and New York: Pluto Press, 2010) and (ed.) Law after Ground Zero (2002).He is currently working on a book on Islamic Law and British colonial India and coediting Injustice and Memory: Faith in Human Rights (Ashgate 2015).



Nimer Sultany



Nimer Sultany is Lecturer in Public Law, School of Law, SOAS, University of London. Previously, he was Postdoctoral Fellow at SUNY Buffalo Law School (2012-2013). He holds an SJD from Harvard Law School; an LL.M. from University of Virginia; an LL.M. from Tel Aviv University; and an LL.B. from the College of Management. He practiced human rights law in Israel/Palestine, and was the director of the Political Monitoring Project at Mada al-Carmel - The Arab Research Center for Applied Social Research. He has written widely on constitutional democracy, Islamic Law, Israeli jurisprudence in relation to the occupation, and on the lack of citizenship for the Palestinian minority in Israel. His op-eds appeared in Arabic, Hebrew, and English in numerous media outlets, including: The Boston Globe, The Miami Herald, The Guardian, Buffalo News, Haaretz, and Al-Quds al-Arabi.

Ahmed Abu-Tawahina



Ahmed Abu-Tawahina, a Palestinian, was born in October 1960, in Deir El-Ballah- Gaza Strip-Palestine, and lives in Gaza-Palestine. He studied BA, MA and PHD in the field of Psychology and Clinical Psychology at Ain-Shams University in Egypt. He is a human rights and peace activist; He worked at Gaza Community Mental Health Programme as a Psychologist, Clinical Psychologist, Deputy Director General and the Director General. He is the founder and the Director of Dignity institution for mental health and human rights. He is a Member of many local and national health and human rights organizations. Dr. Abu-Tawahina participated and attended several international, national and local conferences and workshops. Dr. Abu-Tawahina publishes extensively on issues of peace, civil society, human rights and mental health.

Limor Yehuda



Limor Yehuda is a human rights attorney and a social activist. After working as a prosecutor with the district attorney's office in Jerusalem, Limor spent six years at Israel's Supreme Court as a legal assistant and member of Chief Justice Aharon Barak's legal team. Following her work at the court Limor joined the Association for Civil Rights in Israel (ACRI) where she directed the department for human rights in the Occupied Territories and litigated human rights cases before Israel's High Court of Justice. Limor is currently a research fellow and PhD candidate at the Hebrew University in Jerusalem. Her research aims to explore the applicability of the legal norm of equality to the normative framework of ethno-national conflict resolution in general and the Israeli-Palestinian conflict in particular. In addition to her academic work, Limor is a founding member of "Two States, One Homeland", a political movement focused on offering a new paradigm to the resolution of the Israeli-Palestinian conflict. The movement advocates for a modified confederacy model, and aims to replace the widely accepted discourse of separation with one focusing on equality, mutual respect and partnership.

ABOUT INDEPENDENT JEWISH VOICES -- OUR DECLARATION

A Time To Speak Out: Independent Jewish Voices

We are a group of Jews in Britain from diverse backgrounds, occupations and affiliations who have in common a strong commitment to social justice and universal human rights. We come together in the belief that the broad spectrum of opinion among the Jewish population of this country is not reflected by those institutions which claim authority to represent the Jewish community as a whole. We further believe that individuals and groups within all communities should feel free to express their views on any issue of public concern without incurring accusations of disloyalty.

We have therefore resolved to promote the expression of alternative Jewish voices, particularly in respect of the grave situation in the Middle East, which threatens the future of both Israelis and Palestinians as well as the stability of the whole region. We are guided by the following principles:

- 1. Human rights are universal and indivisible and should be upheld without exception. This is as applicable in Israel and the occupied Palestinian territories as it is elsewhere.
- 2. Palestinians and Israelis alike have the right to peaceful and secure lives.
- 3. Peace and stability require the willingness of all parties to the conflict to comply with international law.
- 4. There is no justification for any form of racism, including anti-Semitism, anti-Arab racism or Islamophobia, in any circumstance.
- 5. The battle against anti-Semitism is vital and is undermined whenever opposition to Israeli government policies is automatically branded as anti-Semitic.

These principles are contradicted when those who claim to speak on behalf of Jews in Britain and other countries consistently put support for the policies of an occupying power above the human rights of an occupied people. The Palestinian inhabitants of the West Bank and Gaza Strip face appalling living conditions with desperately little hope for the future. We declare our support for a properly negotiated peace between the Israeli and Palestinian people and oppose any attempt by the Israeli government to impose its own solutions on the Palestinians.

It is imperative and urgent that independent Jewish voices find a coherent and consistent way of asserting themselves on these and other issues of concern. We hereby reclaim the tradition of Jewish support for universal freedoms, human rights and social justice. The lessons we have learned from our own history compel us to speak out. We therefore commit ourselves to make public our views on a continuing basis and invite other concerned Jews to join and support us.
